## Know Your R&D Pre-notification Deadline

Use the chart below to check the exact pre-notification deadline based on your year-end date — missing it means you won't be able to submit a claim for that period.

IF YOUR YEAR END IS:	YOU MUST PRE-NOTIFY BY:
OCTOBER 2024 If the end date of your accounting period is 31 October 2024 + you are a new claimant, or you have not made a claim since 30 Apr 2022	You must submit the claim notification form between 01 November 2024 and 30 April 2025. → Your deadline is 30 April 2025.
<b>NOVEMBER 2024</b> If the end date of your accounting period is 30 November 2024 + you are a new claimant, or you have not made a claim since 30 May 2022	You must submit the claim notification form between 01 December 2024 and 30 May 2025. → Your deadline is 30 May 2025.
<b>DECEMBER 2024</b> If the end date of your accounting period is 31 December 2024 + you are a new claimant, or you have not made a claim since 30 Jun 2022	You must submit the claim notification form between 01 January 2025 and 30 June 2025. → Your deadline is 30 June 2025.
<b>JANUARY 2025</b> If the end date of your accounting period is 31 January 2025 + you are a new claimant, or you have not made a claim since 31 Jul 2022	You must submit the claim notification form between 01 February 2025 and 31 July 2025. → Your deadline is 31 July 2025.
FEBRUARY 2025 If the end date of your accounting period is 28 February 2025 + you are a new claimant, or you have not made a claim since 28 Aug 2022	You must submit the claim notification form between 01 March 2025 and 28 August 2025. → Your deadline is 28 August 2025.
MARCH 2025 If the end date of your accounting period is 31 March 2025 + you are a new claimant, or you have not made a claim since 30 Sep 2022	You must submit the claim notification form between 01 April 2025 and 30 September 2025. → Your deadline is 30 September 2025.
APRIL 2025 If the end date of your accounting period is 30 April 2025 + you are a new claimant, or you have not made a claim since 30 Oct 2022	You must submit the claim notification form between 01 May 2025 and 30 October 2025. → Your deadline is 30 October 2025.
MAY 2025 If the end date of your accounting period is 31 May 2025 + you are a new claimant, or you have not made a claim since 30 Nov 2022	You must submit the claim notification form between 01 June 2025 and 30 November 2025. → Your deadline is 30 November 2025.
<b>JUNE 2025</b> If the end date of your accounting period is 30 June 2025 + you are a new claimant, or you have not made a claim since 30 Dec 2022	You must submit the claim notification form between 01 July 2025 and 30 December 2025. → Your deadline is 30 December 2025.
