<p>NOVEMBER 2024 If the end date of your accounting period is 30 November 2024 + you are a new claimant, or you have not made a claim since 30 May 2022</p>	<p>You must submit the claim notification form between 01 December 2023 and 30 May 2025. → Your deadline is 30 May 2025.</p>
<p>DECEMBER 2024 If the end date of your accounting period is 31 December 2024 + you are a new claimant, or you have not made a claim since 30 Jun 2022</p>	<p>You must submit the claim notification form between 01 January 2024 and 30 June 2025. → Your deadline is 30 June 2025.</p>
<p>JANUARY 2025 If the end date of your accounting period is 31 January 2025 + you are a new claimant, or you have not made a claim since 31 Jul 2022</p>	<p>You must submit the claim notification form between 01 February 2024 and 31 July 2025. → Your deadline is 31 July 2025.</p>
<p>FEBRUARY 2025 If the end date of your accounting period is 28 February 2025 + you are a new claimant, or you have not made a claim since 28 Aug 2022</p>	<p>You must submit the claim notification form between 01 March 2024 and 28 August 2025. → Your deadline is 28 August 2025.</p>
<p>MARCH 2025 If the end date of your accounting period is 31 March 2025 + you are a new claimant, or you have not made a claim since 30 Sep 2022</p>	<p>You must submit the claim notification form between 01 April 2024 and 30 September 2025. → Your deadline is 30 September 2025.</p>
<p>APRIL 2025 If the end date of your accounting period is 30 April 2025 + you are a new claimant, or you have not made a claim since 30 Oct 2022</p>	<p>You must submit the claim notification form between 01 May 2024 and 30 October 2025. → Your deadline is 30 October 2025.</p>
<p>MAY 2025 If the end date of your accounting period is 31 May 2025 + you are a new claimant, or you have not made a claim since 30 Nov 2022</p>	<p>You must submit the claim notification form between 01 June 2024 and 30 November 2025. → Your deadline is 30 November 2025.</p>
<p>JUNE 2025 If the end date of your accounting period is 30 June 2025 + you are a new claimant, or you have not made a claim since 30 Dec 2022</p>	<p>You must submit the claim notification form between 01 July 2024 and 30 December 2025. → Your deadline is 30 December 2025.</p>
